The Board highlighted activities and meetings attended since the last Board meeting.

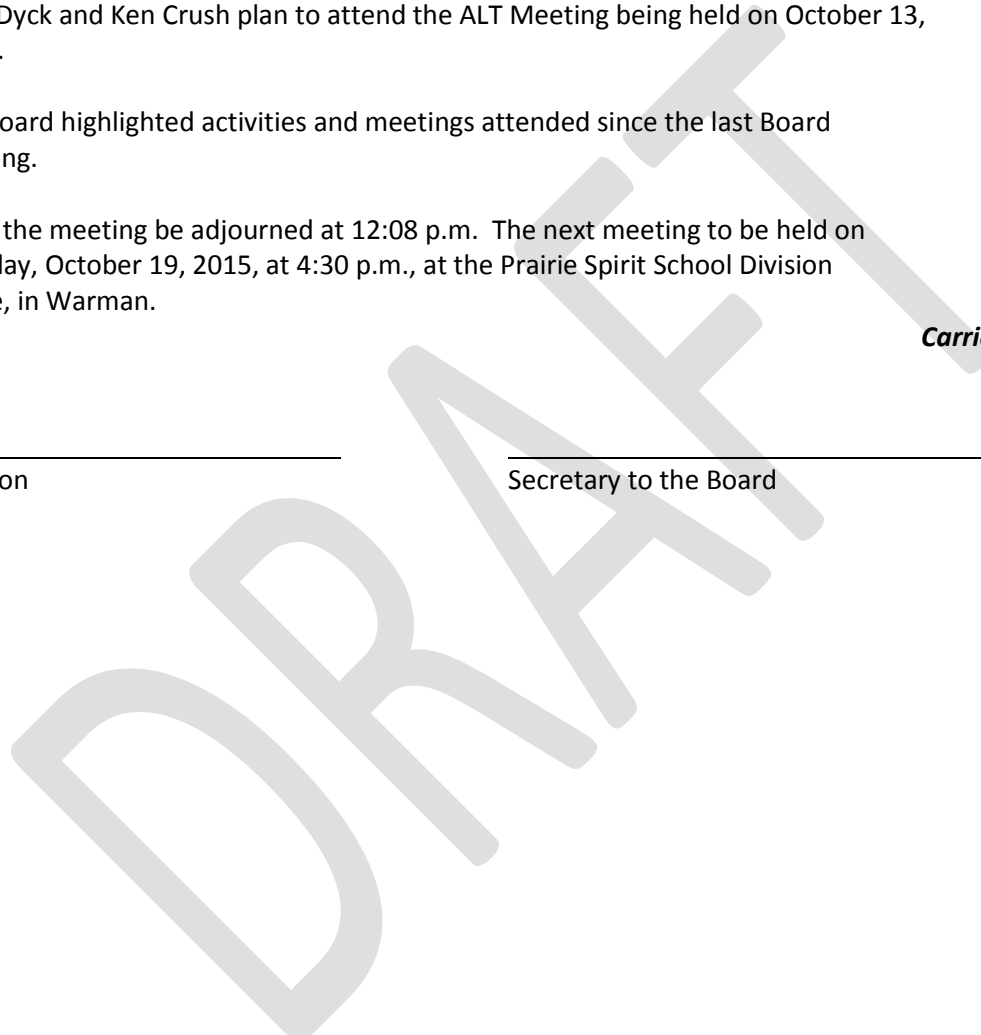
